## **ELIGIBILITY**

Whilst any interested party is welcome to attend, the Association's Constitution stipulates the following:

MEMBERSHIP CRITERIA/VOTING RIGHTS (Refer to the Silverdale Business Constitution for full details) A person shall be entitled to be a Full Member of the Association if the person:

- 5.2.1 owns one or more commercially rated properties within the BID Targeted Rating Area; or
- 5.2.2 trades within one or more commercially rated properties within the BID Targeted Rating Area and who operates a business from those premises for not less than 50 business days a year; and
- 5.2.3 has not previously been expelled from the Association, unless the Executive Committee has resolved to readmit that person under Rule 11.6.
- 5.3 In circumstances where a vote will be held or a motion be moved, only one vote is permitted per represented business.

To be eligible to vote you must have completed the necessary membership forms and forwarded them to arrive with the Association prior to the date for the Annual General Meeting.
